NOTICE TO APPROPRIATORS OF GROUNDWATER IN THE LARAMIE COUNTY CONTROL AREA

The following groundwater applications were received by the State Engineer's Office. Upon conclusion of advertising and public comment, the applications will be considered by the Laramie County Control Area Advisory Board for their recommendation.

Te Velde Family Trust: Temporary Filing Numbers U.W. 46-4-195, 46-5-195, 46-6-195, and 46-7-195. All four applications are for domestic and miscellaneous (feedlot operations) uses. Three wells will be completed in the Cretaceous Lance Formation at an estimated depth of 450-550 feet, and one well (U.W. 46-7-195) in the Cretaceous Fox Hills Sandstone at approximately 1000-1200 feet. Multiple wells are proposed due to uncertainty in the water supply yield of the target formations, and the need for redundancy in water supply.

The three Lance Formation wells will be located in the following quarter-quarters of T13N, R63W, Section 28: SWSE, SESW, and SWSW. Each application requests 60 gallons per minute (GPM) and 39 acre-feet per year (AFY). The Fox Hills well will be in T13N, R63W, Section 33, NWNE. The application requests 120 GPM and 120 AFY.

The proposed well will be located in the SW1/4, SE1/4 of Section 6, T12N, R61W. The estimated well depth is 900 feet with a maximum yield of 200 gallons per minute (gpm), and a maximum volumetric quantity of 322 acre-feet/year.
