## Important Message from Range

Lifeline is a government program to help make communication services more affordable for low-income consumers. Lifeline allows customers to receive a discount for phone service or qualifying broadband service. Only eligible consumers may enroll.

Participation in Medicaid, Supplemental Nutrition Assistance Program (SNAP) (Food Stamps), Federal Public Housing Assistance (FPHA), Veterans Pension or Survivors Benefit Programs or Supplemental Security Income (SSI) can qualify you for Lifeline.
