The kids and parents are always looking to improve and participate in their sport. This time of year rodeos are far and few in between, especially for the youth. On January 20th about five miles northwest on road 212 out of Pine Bluffs there was an indoor rodeo for the youth. This indoor rodeo was set up for the tough cowboys and cowgirls that were determined ride. The event was the FAB Rodeo Extreme Shootout. This was the start of their season.

FAB stands for 'Fast Action Braxton.' A young lad with a vision to make something great out of what his own siblings love to do. Plus, he loves to do it, too. FAB was a nickname the boy received from Chad Berger after talking to the boy at Cheyenne Frontier Days. He was determined to be the best, youngest stock contractor in the sport.

The rodeo hosted 15 contestants for the evening. The ages of the youth ranged from three years old to 15 years old. It was a frigid night but the hot coffee and hot chocolate with great food was being served by Mobile Munchies. She was always making sure everyone was warm from the inside out.

The contestants had the chance and the opportunity to strut their aura of how great they would be performing.

Each one was introduced with their age and where they came from. Some had come from Laramie and Grover, and of course there were locals kids. Along with the contestants they inducted the judges and bullfighters. The judges were Toney Hall and David Sweley. The Bull fighters were Joseph Adams and Eli Gore. Everyone was patient and made sure the contestants got on the animals properly.

The mutton busting sheep was huge with lots of wool surrounding it for the rider to hang on to. Some went backwards where others were just hoping to stay on. The sheep had its up and down times with the riders. The Mutton Busting winner was Eliza Sepulveda at the age of five years old. She said, "I do not want to do that again."

Calfriding is the beginning for the youth to ride rough stock at the rodeos. There were five contestants starting their career in rodeo. Some contestants did great on coming out of the chute. Others were just learning. It takes skill to find balance with one arm hanging in the breeze on a moving animal. The Calf riding winner was Rowdy Angland at the ripe old age of seven years old. He and his family are from Australia and they are here helping train horses in Grover, Colorado.

The steer riding is the next level before bulls. The riders have to stay on the steer for eight seconds to be able to have a qualified ride. The top score wins the event. The Steer riding winner is Casson Squibbs at the age of

The next two events are done on ponies. These ponies range from mini ponies on up. These little horses love to put their all into the sport. You can believe they know every trick in the book to get a rider off of them. The pony broncs range from bareback to saddle bronc. At this rodeo they had combined the two. The winner of Pony Broncs was Clay Angland, (Australia) at the age of five years old.

The last event of the evening was Pony Racing. There were two teams for the night, boys vs almost girls.

The event is same as the wild horse race accept for younger contestants and ponies with attitudes instead of horses. The winning team was Midgets with Attitude, Kiera Acklin as the Mugger, Kaycee Crowton as Shanker and Jace Sinner as the Rider.

It was an eventful night and the contestants worked hard to master their skills. This the first rodeo of the season for FAB rodeo. Justin Erickson and Shelby Crowton that put this event on, believe the rodeo went very well and cannot wait to have more. They said, "It is all about the kids at the FAB rodeo and giving these kids what they need to become legends in the future." This is just the beginning of the season.
